2021 Annual Homeowner's Meeting

The Annual Homeowner's Meeting was held (via Zoom) on Wednesday, April 7. A quorum was reached by proxy & with homeowners in attendance. PacRim Property Manager, Cedric Burden, reviewed & reported on last year's minutes & 2021-22 budget packet; the Board of Directors summarized a yearly report of activities; reported on plans for the upcoming year; & participants asked questions & gave input. Minutes from this meeting are provided to all homeowners in the 2022 Annual Homeowner's Association meeting packet (date tba).

A Few Highlights:

- A new contract w/Kelly's for spring/ summer lawn care was approved;
- The Property Mgr. secured a new CPA for ECHOA auditing services;
- Dead tree mitigation work was conducted on 5/13;
- The spring-walk through occurred 6/7;
- Notices went to homeowners re. MOA & ECHOA garbage/waste receptacles; operating bed & breakfast businesses from the home (not allowed); & number of pets generally allowed (2); &
- A new operating budget was approved.

Dead Tree Mitigation



The ECHOA approved a plan to conduct dead tree mitigation on ECHOA common area lands. To help mitigate possible fire danger or hazard, the ECHOA has contracted with Tall Trees company. On May 13, Tall Trees was able to remove 35-40 of the 50 some trees the Board had marked for removal. More work is planned for 2022. In addition, the ECHOA will be identifying & contacting other adjacent property stake-

holders (federal, state, & private) to explore general area dead tree/brush fire prevention & mitigation efforts in coming years. In the Spring/Summer 2021 newsletter, homeowners were encouraged to conduct their own assessment of home fire safety practices.
